You must provide enough ribs and or chicken for six judges to taste. You will be scored on “Appearance, Taste and Tenderness”.
Special Note: You must also provide some type of ground cover, a tarp or plastic sheeting, enough to lie on the ground under your entire cooking area. If you do not have a ground cover you will not be allowed to cook.

Judging will begin at 2:00 for the Chicken and 2:30 for the Ribs. Meat must be turned in at this time. Awards will begin at 4:00 along with the KCBS awards.
